### RESOLUTION NO. 0221-2021

**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLO R. CERILLES, OF DUMALINAO, ZAMBOANGA DEL SUR, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN DEPARTMENT OF LABOR AND EMPLOYMENT REGION-IX REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. ROY L. BUENAFE FOR THE IMPLEMENTATION OF TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) PROGRAM IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her to enter into a Memorandum of agreement by and between Department of Labor and Employment Region –IX represented by its Regional Director, Atty. Roy L. Buenafe for the implementation of TUPAD Program in the Municipality of Dumalinao, Zamboanga del Sur;

**WHEREAS**, under D.O No. 219, Series of 2020, the TUPAD Program of DOLE, providing assistance to help displaced or to be displaced workers in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence of natural disaster, calamities, or armed



conflicts that affect their economic base and to augment the meager income of the underemployed and seasonal workers;

**WHEREAS**, the Local Government Unit of Dumalinao, aiming to provide basic services especially workers who are economically affected in this time of pandemic within the locality;

**WHEREAS**, it is necessary to implement this TUPAD Program in the municipality, together with Department of Labor and Employment Region –IX in order to help and protect seasonal worker;

**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ZENaida C. LOSABIA** the body resolved, as it hereby resolves to authorize the Local Chief Executive to enter into a Memorandum of agreement by and between Department of Labor and Employment Region –IX represented by its Regional Director, Atty. Roy L. Buenafe for the implementation of TUPAD Program in the Municipality of Dumalinao, Zamboanga del Sur.


