### **RESOLUTION NO. 0222-B-2023**


DECLARING VALID IN ITS ENTIRETY THE BARANGAY ORDINANCE NO. 1 SERIES OF 2023, OF THE BARANGAY LOCAL GOVERNMENT UNIT OF TINA, DUMALINAO, ZAMBOANGA DEL SUR, ENTITLED "AN ORDINANCE OF THE BARANGAY TAX CODE OF BARANGAY TINA, DUMALINAO, ZAMBOANGA DEL SUR".

WHEREAS, presented for consideration and appropriate action is the Barangay Tax Code of Tina, Dumalinao, Zamboanga del Sur, which was referred to the SB Committee on Good Government and Public Accountability and Finance for further study;

**WHEREAS**, the review and evaluation process by the committees confirmed that the enactment of the aforesaid ordinance is within the power of the sangguniang barangay concerned as provided under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the said committees recommended declaring the Barangay Ordinance No. 1 Series of 2023, of Barangay Tina valid and operative;





WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ARNOLD L. FLORES the body resolved, as it hereby resolves to declare valid in its entirety the Barangay Ordinance No. 1 Series of 2023 of the Barangay Local Government Unit of Tin, Dumalinao, Zamboanga del Sur, entitled "An Ordinance of the Barangay Tax Code of Barangay Tina, Dumalinao, Zamboanga del sur".
