RESPECTFULLY REQUESTING THE HONORABLE CONGRESSWOMAN JEYZEL VICTORIA C. YU, 2ND DISTRICT, PROVINCE OF ZAMBOANGA DEL SUR TO FURNISH THIS AUGUST BODY A COPY OF UPDATED/NEW GUIDELINES ON THE RECLASSIFICATION OF MUNICIPALITIES FROM 4TH CLASS TO 3RD CLASS AND UPWARD

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to respectfully request the Honorable Congresswoman Jeyzel Victoria C. Yu of the Second District of Zamboanga del Sur to furnish this August Body a copy of updated/new guidelines on the reclassification of municipalities from 4th class to 3rd class and upward;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:





WHEREAS, said updated/new guidelines on reclassification of municipalities shall guide the Honorable Members of Sangguniang Bayan on determining the impact and effects of reclassification of municipalities including the preparation of necessary requirements whenever a plan in applying for reclassification of the municipality be pursued;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES and severally seconded, the body resolved, as it hereby resolved to respectfully request the Honorable Congresswoman Jeyzel Victoria C. Yu of Second District of Zamboanga del Sur to furnish this August Body a copy of updated/new guidelines on the reclassification of municipalities from 4th class to 3rd class and upward.
