RESOLUTION NO. 0227-2021

RESOLUTION REFERRING BACK THE BARANGAY TAX CODE OF PANTAD TO SANGGUNIANG BARANGAY, COMMITTEE ON RULES AND GOOD GOVERNANCE OF BARANGAY PANTAD, DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, the Sangguniang Bayan is mandated under the law to review the approved ordinance and resolution of Sangguniang Barangay in order to determine whether such is beyond the power of the Sangguniang Bayan concerned or whether the barangay ordinance and resolution are consistent with law;

WHEREAS, this august body was presented with Resolution No. 012-2021, dated August 9, 2021 of Barangay Pantad, Dumalinao, Zamboanga del Sur for review, which was referred to the SB Committee on Rules and Good Governance for further study;

WHEREAS, after thorough review and evaluation of the subject resolution, the Committee reported that pursuant to Section 132, of Republic Act 7061 otherwise known as the Local Government Code of 1991 provides that the power to impose tax, fee, or charge or to generate revenue under this Code shall be exercised by

the sanggunian of local government unit concerned through an appropriate ordinance and not a mere resolution;

WHEREAS, the Committee recommended to refer back the subject resolution to Sangguniang Barangay of Pantad, Committee on Rules and Good Governance for further review and scrutiny;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO G. LIGAN** the body resolved, as it hereby resolves to refer back the Barangay Tax Code of Pantad to Sangguniang Barangay, Committee on Rules and Good Governance of Barangay Pantad, Dumalinao, Zamboanga del Sur.


