## **RESOLUTION NO. 0229-2021**

RESOLUTION RESPECTFULLY REQUESTING ATTY. MARGIE T. JAMES-LUMASAG, MPA REB, PROVINCIAL ASSESSOR OF THE PROVINCE OF ZAMBOANGA DEL SUR TO APPRAISE THE VALUE AND TO CONDUCT AN OCULAR INSPECTION OF THE PROPOSED LAND TO BE PURCHASED BY THE LOCAL GOVERNMENT UNIT OF DUMALINAO, LOCATED AT BARANGAY BANTA-AO, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, there is a proposed land to purchase by the Local Government Unit of Dumalinao, Zamboanga del Sur, for Covid-19 isolation and for other purposes;

WHEREAS, the negotiated sale of land is subject for the assessment of value of the property;
