### RESOLUTION NO. 0229-2021

**RESOLUTION RESPECTFULLY REQUESTING ATTY. MARGIE T. JAMES-LUMASAG, MPA REB, PROVINCIAL ASSESSOR OF THE PROVINCE OF ZAMBOANGA DEL SUR TO APPRAISE THE VALUE AND TO CONDUCT AN OCULAR INSPECTION OF THE PROPOSED LAND TO BE PURCHASED BY THE LOCAL GOVERNMENT UNIT OF DUMALINAO, LOCATED AT BARANGAY BANTA-AO, DUMALINAO, ZAMBOANGA DEL SUR.**
