AUTHORIZING THE HONORABLE MUNICIPAL MAYOR JUNAFLOR S. CERILLES, RMT, MAGD AND THE MUNICIPAL TREASURER, GUALBERTO U. GEMINA, JR., TO RE-OPEN AN ACCOUNT UNDER THE ACCOUNT NAME OF LGU DUMALINAO JHCSC ESU WITH ACCOUNT NUMBER LBP 0522-1281-80 WHICH HAD BEEN DORMANT FOR PURPOSES OF UPDATING OF TRANSACTIONS PRIOR TO ITS CLOSURE AND SHALL BE JOINT SIGNATORIES TO ALL TRANSACTIONS THEREWITH AT LANDBANK OF THE PHILIPPINES. **PAGADIAN CITY BRANCH**

WHEREAS, presented for consideration and appropriate action is the request of Municipal Treasurer, Gualberto U. Gemina, Jr. to authorize him and the Municipal Mayor, Junaflor S. Cerilles, RMT, MAGD to re-open an account under the account name of LGU Dumalinao JHCSC ESU with account number LBP 0522-1281-80 which had been dormant for purposes of updating of transactions prior to its closure and shall be joint signatories to all transactions therewith at Landbank of the Philippines, Pagadian City Branch;

WHEREAS, Section 445 (a) (1), Article II of the Local Government Code of 1991, provides that the Municipal Vice-Mayors, City Vice-Mayors and Provincial Vice-Governors, respectively are empowered and authorized to sign all warrants drawn on the municipal, city, and provincial treasury for all expenditures appropriated for the operation of the sangguniang bayan, sangguniang panlungsod and sangguniang panlalawigan;
