**RESOLUTION NO. 0235-2023**

**AUTHORIZING THE REALLOCATION OF FUNDS AMOUNTING TO THREE HUNDRED FIFTY THOUSAND PESOS (PHP350, 000.00) FROM REBOKON FOOT BRIDGE PROJECT TO THE CONSTRUCTION OF MULTIPURPOSE COVERED COURT AT BARANGAY CUATRO-CUATRO AND INSTALLATION OF WOOD STALL BOOTH WITH ELECTRICAL CONNECTIONS AT THE MUNICIPAL GROUND FROM THE SAME EXPENSE CLASS OF CAPITAL OUTLAY UNDER THE OFFICE OF THE MUNICIPAL MAYOR OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the request of the Local Chief Executive to reallocate the funds amounting to Three Hundred Fifty Thousand Pesos (Php350, 000.00) from Rebokon Footbridge Project to the construction of Multipurpose covered court at Barangay Cuatro-cuatro and installation of wood stall booth with electrical connections at the Municipal Ground from the same expense class of Capital Outlay under the Office of the Municipal Mayor of LGU-Dumalinao;

**WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



**WHEREAS**, the LGU-Dumalinao has allocated funds for the Rebokon Foot Bridge Project under the Capital Outlay budget of the continuing funds from the Office of the Municipal Mayor amounting to Three Hundred Fifty Thousand Pesos (Php350, 000.00), which is an available source for the reallocation of funds in the same office, as follows:

**WHEREAS**, the Municipal Budget Officer had certified that as per the book of accounts of the said office, the item is available as of date and can be reallocated;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolved, to reallocate the funds amounting to Three Hundred Fifty Thousand Pesos (Php350, 000.00) from Rebokon Footbridge Project to the construction of Multipurpose covered court at Barangay Cuatro-cuatro and installation of wood stall booth with electrical connections at the Municipal Ground from the same expense class of Capital Outlay under the Office of the Municipal Mayor of the Local Government Unit of Dumalinao.
