RESOLUTION NO. 0237-2021

RESOLUTION REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO RECONSTITUTE THE PERSONNEL SELECTION BOARD (PSB) OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Human Resource Management Officer (HRMO) to request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD to reconstitute the Personnel Selection Board (PSB) of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, under Article 166 of Implementing Rules and Regulations of the Local Government Code of 1991 provides that there shall be established in every province, city, and municipality, a Personnel Selection Board (PSB) to assist the Local Chief Executive or where applicable, the presiding officer of the sanggunian, in the judicious and objective selection of personnel for employment as well as for promotion;

WHEREAS, the Personnel Selection Board (PSB) shall be composed of the Local Chief Executive or his duly authorized representative as chairman, and members to be determined by resolution of the sanggunian concerned in accordance with pertinent civil service law, rules, and regulations;





WHEREAS, Executive Order No. 138 series of 2021, provides a definition of standards for the delivery services; strategy for the capacity development of the LGUs; framework for monitoring and performance assessment of the LGUs; and an organizational effectiveness proposal to strengthen the department/agency in assuming "steering functions" as part of the devolution efforts;

WHEREAS, the august body finds the importance to reconstitute the Personnel Selection Board (PSB) for the convention, to implement the evaluation and regulation of the applicants for the proposed positions that shall be created in the Staffing Pattern and/or Organizational Structure in the LGU Dumalinao which is in line to the implementation of Devolution Transition Plan (DTP) in the locality;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO G. LIGAN the body resolved, as it hereby resolves to request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD to reconstitute the Personnel Selection Board (PSB) of the Municipality of Dumalinao, Zamboanga del Sur.
