RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLO R. CERILLES, RMT, MAGD TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN DEPARTMENT OF AGRICULTURE REPRESENTED BY ITS SECRETARY HONORABLE WILLIAM D. DAR, Ph.D. FOR THE IMPLEMENTATION OF PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to enter into a Memorandum of Agreement by and between Department of Agriculture for the implementation of Philippine Rural Development Project (PRDP) of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, the Local Government Unit is mandated to provide agricultural support services, agricultural extension and on-site research services and facilities to agricultural areas and stakeholders;

WHEREAS, the Local Government Unit of Dumalinao, through its Local Chief Executive, manifested its interest to participate in the projects of the PRDP in order to promote and support the Rural Agri-Fishery Enterprise and Productivity Enhancement especially in the locality;




