### **RESOLUTION NO. 0244-2023**

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ISSUE AN EXECUTIVE ORDER MANDATING THE CHIEF OF POLICE OF THE MUNICIPAL POLICE STATION OF DUMALINAO TO CONDUCT A SECURITY ASSESSMENT FOR THE CONSIDERATION OF THE FORMER'S OFFICE WHETHER OR NOT TO APPROVE ALL APPLICATIONS SUBMITTED IN HER OFFICE SUCH AS, PERMITS FOR DISCOS, CONCERTS, OR ANY RELATED ACTIVITIES WITHIN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented for consideration and appropriate action is the request of PLT. Derf Jay S. Maquinta, Chief of Police, Municipal Police Station of Dumalinao to request the Local Chief Executive to issue an Executive Order mandating the Chief of Police of the MPS-Dumalinao to conduct a security assessment for the consideration of the former's office whether or not to approve all applications submitted in her office such as, permits for discos, concerts, or any related activities within the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective

governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the safety and well-being of the residents of Dumalinao and its visitors, are of utmost importance of the security assessment and it is essential to ensure proper measures are in place to prevent and address any security concerns associated with such events;

**WHEREAS**, large public gatherings such as discos, concerts, and related activities have the potential to impact public safety and security of the said events;

WHEREAS, the security assessment shall include, but not be limited to, evaluating the venue's security infrastructure, crowd management plans, emergency response protocols, and any potential risks associated with the event;

WHEREAS, the Office of the Municipal Mayor shall forward all applications of permits of the abovementioned events to the MPS-Dumalinao within two (2) days upon receipt thereof. In the same manner, the latter shall submit its findings and recommendations to the Office of the Mayor within two (2) days before the scheduled event:

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JESSIE NIEL C. PAULO, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to issue an Executive Order mandating the Chief of Police of the Municipal Police Station of Dumalinao to conduct a security assessment for the consideration of the former's office whether or not to approve all applications submitted in her office such as, permits for discos, concerts, or any related activities within the Municipality of Dumalinao, Zamboanga del Sur.

**LET** the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
