**RESOLUTION NO. 0246-A-2023**

**FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE AND THE CHAIRPERSON OF THE MUNICIPAL PEACE AND ORDER AND PUBLIC SAFETY COUNCIL, HONORABLE MAYOR JUNAFLO S. CERILLES, RMT, MAGD, TO ALLOCATE FUNDS FOR THE "PAILAW PROJECT" OF THE MUNICIPAL POLICE STATION-DUMALINAO WITHIN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Jessie Niel C. Paulo to favourably request the Local Chief Executive and the Chairperson of the MPOC to allocate funds for the "Pailaw Project" of the MPS-Dumalinao within the locality;

**WHEREAS**, under Section 17 of Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates the Local Government Units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

**WHEREAS**, the Municipal Police Station of Dumalinao, headed by PLT. Derf Jay S. Maquinta has proposed the implementation of the "Pailaw Project" to enhance public safety and security in the municipality;

**WHEREAS**, the "Pailaw Project" aims to improve the visibility and lighting in key areas to deter criminal activities and promote a safer environment for the



community. The assistance of funds shall be utilized exclusively for the purchase and installation of lighting fixtures in strategic locations identified by the Municipal Police Station-Dumalinao to enhance public safety;

**WHEREAS**, the August body recognizes the potential positive impact of the "Pailaw Project" on the overall well-being of Dumalinao residents;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JESSIE NIEL C. PAULO**, the body resolved, as it hereby resolves to favorably requesting the Local Chief Executive and the Chairperson of the Municipal Peace and Order and Public Safety Council, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to allocate funds for the "Pailaw Project" of the Municipal Police Station-Dumalinao within the Municipality of Dumalinao, Zamboanga del Sur.
