LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN WORK AND FINANCIAL PLAN 2022; AND 4. PERSONS WITH DISABILITY WORK AND FINANCIAL PLAN 2021 OF THE MUNCIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR
