## **RESOLUTION NO. 0250-2023**

RESPECTFULLY REQUESTING THE HONORABLE GOVERNOR VICTOR J. YU. OF THE PROVINCE OF ZAMBOANGA DEL SUR TO ALLOCATE FUNDS FOR THE PROPOSED ESTABLISHMENT OF COLD STORAGE FACILITIES AT COMMUNITY FISH LANDING CENTER OF BARANGAY PANTAD, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to request the Provincial Governor of Zamboanga del Sur, Hon. Victor J. Yu, to allocate funds for the proposed establishment of Cold Storage Facilities at Community Fish Landing Center of Barangay Pantad, this locality;

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities include, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply system; seawalls, dikes,

drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities, as part of the basic services devolved to the municipalities;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32 013;

WHEREAS, Barangay Pantad plays a pivotal role in the local fishing industry, serving as a vital hub for the community's fishing activities, providing livelihood and sustenance to a significant portion of our population;

WHEREAS, the establishment of Cold Storage Facilities at the Community Fish Landing Center is crucial in preserving the quality of fish and seafood products, ensuring their freshness and safety for both local consumption and potential markets;

WHEREAS, considering the limited resources of the LGU, this august body deemed it necessary to source out funds, hence to appeal to the good Governor, Honorable Victor J. Yu, for financial fund;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. FREDERICK R. BALANDRA, the body resolved, as it hereby resolves to respectfully requesting the Honorable Governor Victor J. Yu, of the Province of Zamboanga del Sur to allocate funds for the proposed establishment of Cold Storage Facilities at Community Fish Landing Center of Barangay Pantad, Dumalinao, Zamboanga del Sur.
