### **RESOLUTION NO. 0255-2021**

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN DAINALYN B. RUPINTA FOR THE LEASE CONTRACT OF LAND LOCATED AT BARANGAY SEBUCAO, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her to enter into a Memorandum of Agreement by and between Dainalyn B. Rupinta for the lease contract of land located at Barangay Sebucao, Dumalinao, Zamboanga del Sur;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capital or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the





municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Ms. Danailyn B. Rupinta is the absolute owner of a parcel of land covered by TCT No. T-48,922 with a total area of Ten Thousand (10,000) Square Meters, more or less, located at Barangay Sebucao, Dumalinao, Zamboanga del Sur;

WHEREAS, a portion of the above-described parcel of land is a source of potable water on which an intake box has been constructed/installed by the Local Government Unit of Dumalinao and at the same time, the said potable water was the source of water to residential, industrial, and commercial areas in the locality;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. ELYNOR S. CORTEZ the body resolved, as it hereby resolves to authorize her to enter into a Memorandum of Agreement by and between Dainalyn B. Rupinta for the lease contract of land located at Barangay Sebucao, Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.

# MEMORANDUM OF AGREEMENT / LEASE CONTRACT

# KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement/Contract of Lease is made and entered into and between the MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR, a public corporation existing under and by virtue of the laws of the Republic of the Philippines, herein represented by HON. JUNAFLOR S. CERILLES, Municipal Mayor and hereinafter called as the LESSEE and DAINALYN B. RUPINTA, of legal age, Filipino citizen, resident of Sebucao, Dumalinao, Zamboanga del Sur, Philippines and hereinafter called as the LESSOR.

#### WITHNESSETH:

WHEREAS, DAINALYN B. RUPINTA are the absolute owner of a parcel of land covered by TCT NO. T-48,922 with a total area of TEN THOUSAND (10,000) SQUARE METERS, more or less, located Barangay Sebucao, Dumalinao, Zamboanga del Sur;

WHEREAS, a portion of the above-described parcel of land is a source of potable water on which an intake box has been constructed/installed by the Local Government Unit (LGU) of Dumalinao, Zamboanga del Sur. The LGU of Dumalinao is presently using the said water source to supply water to residential, industrial and commercial areas and for the other purposes within its area of jurisdiction.

WHEREAS, the LESSOR hereby lease the aforesaid source of water in favour of the aforementioned LESSEE, subject to the following terms and conditions:

- a. THAT this CONTRACT OF LEASE shall take effect starting the month of <u>January 2022</u> to <u>December 31, 2023</u> or with a term of TWO (2) YEARS from the execution hereof. At the expiration of the period of Two (2) years, it is understood that the terms hereof are rendered automatically terminated except when formally RENEWED OR EXTENED under another agreement to be entered into by and between herein parties; and
- b. THAT the LESSEE shall pay an ANNUAL RENTAL to the LESSOR in the amount of FIFTY THOUSAND (PHP 50,000.00) PESOS, Philippine currency without need for further demand at the end of each lease year period. The same scheme of payment or collection shall be observed for the lease period of the year 2023.
- c. THAT payment of the rentals, if by Check shall be made payable to the order of the lessor DAINALYN B. RUPINTA;
- d. THAT during the validity of this contract, the LESSOR shall promptly notify the LESSEE if there be any improvements that the former may introduce or the latter in the same manner shall notify the lessor should any improvements by way of repair, rehabilitation and/or development of the water facilities necessary for the operation of the water source;
- e. THAT the subject matter of the instant covenant shall be LIMITED TO THE ACTUAL AREA WHICH IS ACTUALLY UTILIZED and/or FENCED by the LGU of Dumalinao AS OF THE WRITING AND SIGNING HEREOF. It shall not extend to any other portion/s of the entire property owned by the LESSOR as above-described unless there is a separate or another contract of lease or agreement that shall be formally entered into between herein parties. The LESSEE undertakes to never extend its occupation and enjoyment save that which is the subject hereof which in particular is that which is actually utilized and/or fenced by it as of the writing and signing hereof.

f. THAT the LESSEE shall allocate free water household consumption to the LESSOR.

WHEREAS, any violation of any of the foregoing terms and other applicable law, ordinances, rules and regulations shall be sufficient cause for the revocation of this contract and agreement.

IN WITNESS HEREOF, the parties hereunto set their hands this 21st day of January 2022, at Pagadian City, Zamboanga del Sur, Philippines.
