

RESOLUTION NO. 0256-2023

ADOPTING THE SUPPLEMENTAL NO. 3 OF THE ANNUAL INVESTMENT PLAN (AIP) 2023 OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the Supplemental No. 3 of the Annual Investment Plan 2023 of the Local Government Unit of Dumalinao:

WHEREAS, as mandated by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and other pertinent DILG Circulars, provides that every Local Government Unit is mandated to prepare and submit Annual Investment Plan (AIP) to the Department of Interior and Local Government (DILG) and other concerned agencies, for the preparation of its Annual Budget;

WHEREAS, the Annual Investment Plan 2023 of the Municipality of Dumalinao includes the different programs and activities per sector and sub-sector, the work activities and financial plan for the 20% Development Plan, 5% GAD Plan, 5% DRRM, 1% PWD and Senior Citizen, 1% LCPC, Inter-Agency Aids, Statutory and Contractual Obligations, Personal Services, MOOE, Capital Outlay and other funds from other sources of agencies;

WHEREAS, the Supplemental No. 3 of Annual Investment Plan 2023 has a total fund allocation of Nine Hundred Fifty-Six Thousand One Hundred Forty Pesos and Thirty-Six Centavos (Php956, 140.36) to cover the monetization of elected officials and employee, travel expenses, terminal leave benefits, GSIS and Rice Allowance for Personnel of the Local Government Unit of Dumalinao, Zamboanga del Sur;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. ARNOLD L. FLORES the body resolved, as it hereby resolves to adopt the Supplemental No. 3 of the Annual Investment Plan (AIP) 2023 of the Local Government Unit of Dumalinao, Zamboanga del Sur.
