RESOLUTION NO. 0259-2022

RESOLUTION ADOPTING THE UPDATED LOCAL INVENTORY OF CULTURAL PROPERTY OF THE MUNICIPALITY OF DUMALINAO, ZAMBONGA DEL SUR.

WHEREAS, presented to this august body for appropriate action is the request of Ms. April Thess Malong-Mariano, Designated Municipal Tourism Officer, to adopt the updated Local Inventory of Cultural Property of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 14 (b) of Republic Act No. 10066 or the National Historical Heritage Act of 2009 requires local government units to establish and maintain a local cultural property or registry;

WHEREAS, pursuant to Joint Memorandum Circular No. 2018-01 of the National Commission on Culture and Arts (NCCA) and the Department of the Interior and Local Government (DILG) dated October 9, 2018, is enjoining all local government units to establish and maintain a local inventory of cultural property which shall form part of the Philippine Registry of Cultural Property (PRECUP);

WHEREAS, the Office of the Municipal Tourism submitted the updated cultural properties within the municipality for inclusion in the PRECUP, to wit: 1. Subanen Dance; 2. Subanen Dialect; and 3. Lupang Hinirang Song in Subanen Dialect;



WHEREAS, the august body finds the said inventory of municipal cultural properties reflective of the history and culture of the municipality and strongly recommends that these be included in the PRECUP;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. GLEEWIN L. RUBIO** the body resolved, as it hereby resolves to adopt the updated Local Inventory of Cultural Property of the Municipality of Dumalinao, Zamboanga del Sur.
