RESOLUTION NO. 0260-2023

ADOPTING THE PRESIDENTIAL DECREE NO. 1563, ESTABLISHING AN INTEGRATED SYSTEM FOR THE CONTROL AND ERADICATION OF MENDICANCY PROVIDING PENALTIES, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jeziel R. Dagupan to adopt the Presidential Decree No. 1563 in the municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, mendicancy remains a social issue affecting the welfare, dignity, and businesses of our community members in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, the Presidential Decree No. 1563, aimed at establishing an integrated system for the control and eradication of mendicancy, providing penalties,

appropriating funds therefor, and for other purposes, has been promulgated to address this pressing concern;

WHEREAS, all barangay officials, law enforcement agencies, and concerned entities of the locality are hereby directed to extend their full cooperation and support in the implementation of this resolution;

WHEREAS, the August body finds it necessary to adopt and support the implementation of Presidential Decree No. 1563 within its jurisdiction;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JEZIEL R. DAGUPAN, the body resolved, as it hereby resolves to adopt the Presidential Decree No. 1563, establishing an integrated system for the control and eradication of mendicancy providing penalties, appropriating funds therefor, and for other purposes in the Municipality of Dumalinao, Zamboanga del Sur.
