RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR THE TRIPARTITE AGREEMENT BY AND BETWEEN DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD-IX) AND THE CLIENT/BENEFICIARY OF THE BALIK PROBISNYA, BAGONG PAG-ASA PROGRAM (BP2) OF THE DSWD FOR THE IMPLEMENTATION OF LIVELIHOOD ASSISTANCE TO DISPLACE WORKER/FAMILIES CAME FROM URBANIZED CITIES IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented to this august body for appropriate action, is the letter request of KALAHI-Dumalinao to authorize the Local Chief Executive, Honorable Mayor Junaflores S. Cerilles to enter into a Memorandum of Agreement (MOA) for the tripartite agreement by and between Department of Social Welfare and Development (DSWD-IX) and the Client/Beneficiary of the Balik Probinsya, Bagong Pag-asa Program (BP2) of DSWD for the implementation of livelihood assistance to displace workers/families came from urbanized cities in the Municipality of Dumalinao, Zamboanga del Sur;



WHEREAS, pursuant to Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that Local Government Unit has the power to enter into contracts with the authorization by the Sangguniang Bayan through a resolution;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;
