#### **RESOLUTION NO. 0268-2023**

AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ENTER AND SIGN ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE CONSTRUCTION OF FARM-TO-MARKET ROAD IN PUROK IPIL-IPIL AND PUROK GEMELINA, BARANGAY BAGA, MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR IN THE AMOUNT OF FORTY-FIVE MILLION PESOS (PHP45, 000, 000.00).

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to enter and sign on behalf of the LGU-Dumalinao with the Department of Agrarian Reform (DAR) for the construction of Farm-to-Market Road (FMR) in Purok Ipil-ipil and Purok Gemelina, Barangay Baga in the amount of Forty-Five Million Pesos (Php45, 000, 000.00);

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;





WHEREAS, the municipal mayor is empowered by the same Code to enter into Contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Local Government Unit of Dumalinao recognizes the importance of improving agricultural infrastructure to enhance the economic well-being of its constituents. The construction of Farm-to-Market Road in Purok Ipil-ipil and Purok Gemelina, Barangay Baga will facilitate the efficient transport of agricultural products from the production areas to the market;

WHEREAS, the Department of Agrarian Reform (DAR) has expressed its willingness to collaborate with the Local Government Unit of Dumalinao for the construction of the aforementioned Farm-to-Market Road:

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. FREDERICK R. **BALANDRA**, the body resolved, as it hereby resolved to authorize the Local Chief Executive Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to enter and sign on behalf of the Local Government Unit of Dumalingo with the Department of Agrarian Reform (DAR) for the construction of Farm-To-Market Road in Purok Ipil-Ipil and Purok Gemelina, Barangay Baga, Municipality of Dumalinao, Zamboanga del Sur in the amount of Forty-Five Million Pesos (Php45, 000, 000.00).
