#### **RESOLUTION NO. 0273-2022**

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ENTER INTO A CONTRACT OF AGREEMENT BY AND BETWEEN RURAL IMPROVEMENT CLUB – WOMEN EMPOWERMENT MOVEMENT (RIC-WEM) OF BARANGAY MALASIK FOR THE IMPLEMENTATION OF LIVELIHOOD PROGRAM IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her to enter into a contract of agreement by and between Rural Improvement Club – Women Empowerment Movement (RIC-WEM) of Barangay Malasik for the implementation of livelihood program in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, according to the Local Government Code of the Philippines, Local Government Units may enter into joint ventures and such cooperative arrangements with people's and nongovernment organizations to engage in the delivery of certain basic service, capability-building and livelihood projects, and to develop local enterprise designed to improve productivity and income,



diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people;

WHEREAS, the Rural Improvement Club – Women Empowerment Movement (RIC-WEM) of Dumalinao is an accredited association through SB Resolution No. 0122-2020;

WHEREAS, in order to empower RIC-WEM of Barangay Malasik and to give assistance, the LGU-Dumalinao grants a Hog Raising Project amounting to Twenty Thousand Pesos (Php20, 000.00);

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. ZENAIDA C. LOSABIA the body resolved, as it hereby resolves to authorize the Local Chief Executive to enter into a contract of agreement by and between Rural Improvement Club - Women Empowerment Movement (RIC-WEM) of Barangay Malasik for the implementation of livelihood program in the Municipality of Dumalinao, Zamboanga del Sur.
