ADOPTING THE SUPPLEMENTAL BUDGET NO. 5 OF THE ANNUAL INVESTMENT PLAN (AIP) 2023 OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

Contractual Obligations, Personal Services, MOOE, Capital Outlay and other funds from other sources of agencies;

WHEREAS, the Supplemental No. 5 of Annual Investment Plan 2023 has a total fund of Six Million Twenty-Three Thousand Pesos (Php6, 023, 000.00) for the expenditures of Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay of the different offices of the Local Government unit Of Dumalinao, Zamboanga del Sur;
