RESOLUTION NO. 0277-2024

FAVORABLY REQUESTING THE OFFICE-IN-CHARGE OF THE MUNICIPAL POLICE STATION OF DUMALINAO, PLT. DERF JAY S. MAQUINTA AND THE MUNICIPAL TRAFFIC ENFORCER OF DUMALINAO TO REMIND AND REPRIMAND ALL CARGO TRUCKS AND VEHICLES WHO PLACED, PARKED, AND OBSTRUCTED ON THE PROHIBITED PARKING AREA AND WITHIN OR ALONG THE NATIONAL, PROVINCIAL, MUNICIPAL, AND BARANGAY HIGHWAY, STREETS AND ROADS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF DUMALINAO, AS PROVIDED IN THE ORDINANCE NO. 2020-03-437.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Joel L. Famor to request the Office-In-Charge of the Municipal Police Station of Dumalinao and the Municipal Traffic Enforcer of Dumalinao to remind and reprimand all cargo trucks and vehicles who placed, parked, and obstructed on the prohibited parking area and within or along the national, provincial, municipal, and barangay highways, streets and roads within the jurisdiction of the Municipality of Dumalinao, as provided in the Ordinance No. 2020-03-437;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as



powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Municipality of Dumalinao has enacted Ordinance No. 2020-03-437, which strictly prohibits the placement, parking, and obstruction of cargo trucks and vehicles within specified areas along the national, provincial, municipal, and barangay highways, streets, and roads. The proper implementation of the said ordinance is crucial to maintaining public order, safety, and efficient traffic flow within the municipality;


WHEREAS, it has been observed that certain cargo trucks and vehicles continue to violate the provisions of Ordinance No. 2020-03-437 by placing, parking, and obstructing in prohibited areas, causing inconvenience and potential hazards to the public;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;


NOW, THEREFORE, premises above-considered, on motion by **HON. JOEL L. FAMOR**, the body resolved, as it hereby resolved, to favourably request the Office-In-Charge of the Municipal Police Station of Dumalinao, PLT. Derf Jay S. Maquinta and the Municipal Traffic Enforcer of Dumalinao to remind and reprimand all cargo trucks and vehicles who placed, parked, and obstructed on the prohibited parking area and within or along the national, provincial, municipal, and barangay highway, streets and roads within the jurisdiction of the Municipality of Dumalinao, as provided in the Ordinance No. 2020-03-437.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
