**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to request the Local Chief Executive to allocate funds for the proposed construction of Indigenous Peoples Gallery in the locality;

**WHEREAS**, the establishment of an Indigenous Peoples Gallery aligns with our commitment to cultural diversity, inclusivity, and the promotion of local heritage;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;


**NOW, THEREFORE**, premises above-considered, on motion by **HON. ROMEO D. PARILA**, the body resolved, as it hereby resolved, to favourably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD to allocate funds for the proposed construction of Indigenous Peoples Gallery in the Municipality of Dumalinao, Zamboanga del Sur.
