


RESOLUTION NO. 0282-2024

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO BY AND BETWEEN THE MECOLONG NATIONAL HIGH SCHOOL REPRESENTED BY ITS SCHOOL DIVISION SUPERINTENDENT, DR. JEANELYN A. ALEMAN, CESO V, FOR THE IMPLEMENTATION OF WORK IMMERSION PARTNERSHIP IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to enter and sign a Memorandum of Agreement on behalf of the LGU-Dumalinao by and between the MNHS represented by its School Division Superintendent, Dr. Jeanelyn A. Aleman, CESO V, for the implementation of Work Immersion Partnership in the locality;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;





WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance:

WHEREAS, the Local Government Unit of Dumalinao recognizes the importance of education in the development of the students and the community with the primary objective of ensuring that graduates of basic education are ready for employment, entrepreneurship, and higher learning;

WHEREAS, the MNHS has expressed interest in establishing a Work Immersion Partnership with the LGU-Dumalinao;

WHEREAS, the terms and conditions stipulated in the Memorandum of Agreement (MOA) were thoroughly reviewed by this August body and found to be advantageous and within the capacity of the Local Government Unit of Dumalinao, Zamboanga del Sur;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. RHOLLY A. LABANG, the body resolved, as it hereby resolved, to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to enter and sign a Memorandum of Agreement on behalf of the Local Government Unit of Dumalingo by and between the Mecolong National High School represented by its School Division Superintendent, Dr. Jeanelyn A. Aleman, CESO V, for the implementation of Work Immersion Partnership in the Municipality of Dumalinao, Zamboanga del Sur.
