RESOLUTION NO. 0285-2022

RESOLUTION ENDORSING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE SCHOOL-BASED WORK IMMERSION OF SENIOR HIGH SCHOOL STUDENTS, AS THE COURSE REQUIREMENTS WHICH COVERS 240 TRAINING HOURS AND SHALL BE CONDUCTED AT MECOLONG NATIONAL HIGH SCHOOL.

WHEREAS, presented to this august body for appropriate action, the request of Mecolong National High School represented by the school head Ms. Remedios D.
