RESOLUTION ENDORSING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE SCHOOL-BASED WORK IMMERSION OF SENIOR HIGH SCHOOL STUDENTS, AS THE COURSE REQUIREMENTS WHICH COVERS 240 TRAINING HOURS AND SHALL BE CONDUCTED AT TINA NATIONAL HIGH SCHOOL.

WHEREAS, presented to this august body for appropriate action, the request of Tina National High School represented by the school head Mr. Michael Paul M. Carandang to endorse to the Local IATF Council of Dumalinao, Zamboanga del Sur, the school-based work immersion of Senior High School Students, as the course requirements which covers 240 training hours and shall be conducted at Tina National High School;

WHEREAS, the Work Immersion is a required subject for the Technical-Vocational-Livelihood (TVL) track which aims to provide SHS with opportunities to familiarize them with the workplace to stimulate employment and to apply their competencies in the area of specialization;



WHEREAS, this august body acknowledge the importance of this school-based Work Immersion Program which is a course requirement of a student to graduate and at the same time the health and safety of the students and teachers;




