RESOLUTION NO. 0287-2022

RESOLUTION ENDORSING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE SCHOOL-BASED WORK IMMERSION OF GRADE 12 STUDENTS AS THE COURSE REQUIREMENTS OF COMPUTER SYSTEM SERVICING AND FOOD (FISH) PROCESSING WHICH SHALL BE CONDUCTED AT REBOKON AGRICULTURAL AND VOCATIONAL HIGH SCHOOL.

WHEREAS, presented to this august body for appropriate action, the request of Rebokon Agricultural and Vocational High School represented by the school head Mr. Wilson R. Panuncillon to endorse to the Local IATF Council of Dumalinao, Zamboanga del Sur, the school-based work immersion of Grade 12 Students as the course requirements of Computer System Servicing and Food (Fish) Processing which shall be conducted at Rebokon Agricultural and Vocational High School;
