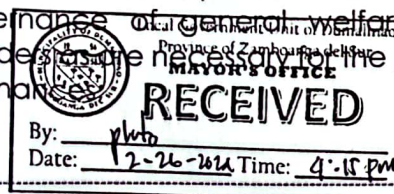

**RESOLUTION NO. 0287-2024**

**RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO ISSUE AN EXECUTIVE ORDER ALLOWING THE REPRESENTATION OF INDIGENOUS COMMUNITY/INDIGENOUS PEOPLE IN THE LOCAL LEGISLATIVE COUNCILS OR POLICY-MAKING BODIES WITHIN THE POLITICAL JURISDICTION OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO EVEN IF NOT OBTAINING THE MANDATORY REQUIREMENTS OF SECTION 6, PARAGRAPHS A AND B OF NCIP ADMINISTRATIVE ORDER NO. 3 SERIES OF 2018 AND UPON THE INITIATIVES OF ICCS/IPS THEREIN.**

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila requesting the Local Chief Executive to issue an Executive Order allowing the representation of IC/IP in the local legislative councils or policy-making bodies within the political jurisdiction of the LGU-Dumalinao even if not obtaining the mandatory requirements of Section 6 paragraphs A and B of NCIP Administrative Order No. 03 Series of 2018 and upon the initiatives of ICCs/IPs therein;

**WHEREAS**, under Section 444, (b), (iii), Article I, Chapter III of the Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that for the efficient, effective, and economical governance of general welfare, the municipal mayor shall issue such executive orders as may be necessary for the proper enforcement and execution of laws and ordinances.

**WHEREAS**, Section 6, (d) of NCIP Administrative Order No. 03 Series of 2018, provides that where the situations in paragraphs a and b above are not obtaining, the concerned LGU may still allow representation in accordance with this Guidelines upon the initiatives of ICCs/IPs therein;

**WHEREAS**, despite efforts to comply with the aforementioned Administrative Order, certain IC/IP individuals or groups within our community may encounter challenges in meeting these requirements due to various factors such as geographic isolation, administrative constraints, or socio-economic conditions;

**WHEREAS**, ensuring the meaningful participation and representation of IC/IP in local governance processes, which is fundamental to upholding their rights, preserving their cultural heritage, and promoting sustainable development within our municipality;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ROMEO D. PARILA** the body resolved, as it hereby resolves to respectfully request the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to issue an Executive Order allowing the representation of IC/IP in the local legislative councils or policy-making bodies within the political jurisdiction of the Local Government Unit of Dumalinao even if not obtaining the mandatory requirements of Section 6 paragraphs A and B of NCIP Administrative Order No. 03 Series of 2018 and upon the initiatives of ICCs/IPs therein.
