RESOLUTION NO. 0290-2024

FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO MANDATE THE OFFICE OF THE MUNICIPAL ENGINEERING TO CONDUCT SITE INSPECTION AND REPAIR AND MAINTENANCE OF THE WATER SOURCE SYSTEM AT BARANGAY MALASIK, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to favorably request the Local Chief Executive to mandate the Office of the Municipal Engineering to conduct site inspection and repair and maintenance of the water source system at Barangay Malasik, this municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the LGU-Dumalinao is mandated to provide clean and reliable water, which is a fundamental human right and a vital component for the well-being and development of communities;



WHEREAS, the water source system located at Barangay Malasik in Dumalinao, Zamboanga del Sur, faces challenges regarding the maintenance and functionality of its water source system;

WHEREAS, the LGU-Dumalinao shall intervene and address the pressing need for the inspection, repair, and maintenance of the water source system in Barangay Malasik;

WHEREAS, the Office of the Municipal Engineering possesses the technical expertise and resources necessary to conduct comprehensive site inspections and execute repair and maintenance tasks effectively;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to mandate the Office of the Municipal Engineering to conduct site inspection and repair and maintenance of the water source system at Barangay Malasik, Dumalinao, Zamboanga del Sur.
