**RESOLUTION NO. 0291-2024**

**AMENDING THE SECTION 48 OF RESOLUTION NO. 035-A-2022, OF THE INTERNAL RULES OF PROCEDURE (IRP) OF THE 12<sup>TH</sup> SANGGUNIANG BAYAN OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Rholly A. Labang to amend the Section 48 of Resolution No. 035-A-2022, of the IRP of the 12<sup>th</sup> Sangguniang Bayan of Dumalinao;

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 103, Rule XVII of its Implementing Rules and Regulations provide, among others, that the Sangguniang Bayan composition shall adopt or update its internal rules of procedure;

**WHEREAS**, the amendment of Section 48 provides the discipline of a members of the council that: a. the sangguniang bayan, on the 1st Monday and 2nd Monday of the month, must wear a white polo or sleeve barong; b. During the 3rd Monday of the month, the sangguniang bayan must wear a polo or long-sleeved barong in any color; c. the sangguniang bayan, on the 4th Monday of the month, must wear formal attire; and d. absent for the whole session should be notified to the Presiding Officer through text, messenger, or call with a valid reason;



**WHEREAS**, in order to guide its proceedings and deliberation during sessions with order, dignity, and decorum and to effectively discharge its legislative functions, the Sangguniang Bayan feels strongly that it should amend and update its internal rules of procedures;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. RHOLLY A. LABANG**, the body resolved, as it hereby resolves to amend the Section 48 of Resolution No. 035-A-2022, of the Internal Rules of Procedure (IRP) of the 12<sup>th</sup> Sangguniang Bayan of the Municipality of Dumalinao, Zamboanga del Sur.
