**RESOLUTION NO. 0298-2022**

**RESOLUTION ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT UPDATED CONTINGENCY PLAN FOR FLASH FLOOD OF BARANGAY REBOKON, DUMALINAO, ZAMBOANGA DEL SUR, FOR CALENDAR YEAR 2022-2025.**

**WHEREAS**, presented to this august body for appropriate action is the request of Mr. Joemar E. Suganob, Municipal Disaster Risk Reduction Management Officer, to adopt the Municipal Disaster Risk Reduction and Management updated Contingency Plan for Flash Flood of Barangay Rebokon, Dumaliniao, Zamboanga del Sur, for Calendar Year 2022-2025;

**WHEREAS**, the Local Government Units (LGU's) are mandated through Republic Act No. 10121 of the Philippine Disaster Risk Reduction and Management Act of 2010 to adopt and implement a coherent, comprehensive, integrated, efficient, and comprehensive disaster risk reduction and management program;

**WHEREAS**, under Republic Act 10121 IRR Rule 6 Section 4 (7), the Municipal Disaster Risk Reduction Management Council (MDRRMC), with the local officials, sector representatives, and other stakeholders, formulated a contingency plan consistent with the prevention, mitigation, preparedness, response, relief and rehabilitation during and after calamity;



**WHEREAS**, this contingency plan for the flash flood of Barangay Rebokon will enable the local government unit to prepare and respond timely, effectively, and appropriately during and after a landslide that might endanger the general public and/or the environment;

**WHEREAS**, it is the primary power, duty, and function of the Sangguniang Bayan as the legislative body of the municipality, to enact ordinances, approved resolutions, and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ELYNOR S. CORTEZ** the body resolved, as it hereby resolves to adopt the Municipal Disaster Risk Reduction and Management updated Contingency Plan for Flash Flood of Barangay Rebokon, Dumalinao, Zamboanga del Sur, for Calendar Year 2022-2025.


