RESOLUTION NO. 0302-2024

RESPECTFULLY REQUESTING THE OFFICE IN CHARGE DISTRICT ENGINEER, DE MIGUEL C. BAYA OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, 2ND ENGINEERING DISTRICT OF ZAMBOANGA DEL SUR, TO RELOCATE SOME OF THE ROAD BARRIERS AT BARANGAY SUMADAT TO BE PLACED AT THE NATIONAL HIGHWAY OF THE SAN ISIDRO LABRADOR PARISH CHURCH OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to respectfully request the OIC District Engineer, De Miguel C. Baya of the DPWH, 2nd Engineering District of Zamboanga del Sur, to relocate some of the road barriers at Barangay Sumadat to be placed at the national highway of the San Isidro Labrador Parish Church of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, the San Isidro Labrador Parish Church of Dumalinao, Zamboanga del Sur, holds significant cultural, religious, and historical importance to the community;

WHEREAS, the safety and convenience of parishioners and visitors attending religious services and events at the San Isidro Labrador Parish Church are of utmost importance;

WHEREAS, it has been observed that road barriers located within Barangay Sumadat, under the jurisdiction of the DPWH 2nd Engineering District of Zamboanga del Sur, could be reallocated to enhance safety measures at the San Isidro Labrador Parish Church;

WHEREAS, relocating these road barriers to the national highway of the San Isidro Labrador Parish Church would serve to better regulate vehicular traffic, providing a safer environment for pedestrians and worshippers;

WHEREAS, the proper placement of these road barriers would also contribute to the preservation of the historical and cultural heritage of the San Isidro Labrador Parish Church;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to respectfully request the OIC District Engineer, De Miguel C. Baya of the DPWH, 2nd Engineering District of Zamboanga del Sur, to relocate some of the road barriers at Barangay Sumadat to be placed at the national highway of the San Isidro Labrador Parish Church of Dumalinao, Zamboanga del Sur.
