RESPECTFULLY REQUESTING THE HONORABLE GOVERNOR VICTOR J. YU OF THE PROVINCE OF ZAMBOANGA DEL SUR THROUGH THE OFFICE OF THE PROVINCIAL ENGINEERING OFFICE TO CONDUCT ROAD CLEARING AND ROAD SPACING OF THE MUNICIPAL STREET FROM GUILINGAN STREET TO DUMALINAO REGIONAL PILOT SCHOOL IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to respectfully request the Honorable Governor Victor J. Yu of the Province of Zamboanga del Sur through the Office of the Provincial Engineering Office to conduct road clearing and road spacing of the municipal street from Guilingan Street to Dumalinao Regional Pilot School in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
