RESOLUTION NO. 0314-2024

FAVORABLY ASKING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R S. CERILLES, RMT, MAGD, TO EXEMPT THE MEMBERS OF THE 12TH SANGGUNIANG BAYAN OF DUMALINAO FROM THE IMPLEMENTATION OF MEMORANDUM NO. 195 SERIES OF 2022 OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Rholly A. Labang to favorably ask the Local Chief Executive to exempt the members of the 12th Sangguniang Bayan of Dumalinao from the implementation of Memorandum No. 195 Series of 2022 of the locality;

WHEREAS, Section 447 (a) (1) Article III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan, as the legislative body of the municipality, shall approve ordinances and resolutions necessary for an efficient and effective municipal government;

WHEREAS, the members of the 12th Sangguniang Bayan of Dumalinao are dedicated public servants committed to the welfare and progress of our municipality;



WHEREAS, Memorandum No. 195 Series of 2022, imposing penalties for absences or tardiness during the flag-raising ceremony, has been implemented within the municipal government;

WHEREAS, the duties and responsibilities of members of the Sangguniang Bayan often require their presence in various official functions and activities, necessitating flexibility in attendance requirements;

WHEREAS, the imposition of penalties for absences or tardiness during the flag-raising ceremony may unduly burden members of the 12th Sangguniang Bayan, impeding their ability to fulfill their duties effectively;

WHEREAS, it is in the best interest of the municipality to ensure that the members of the Sangguniang Bayan can fully dedicate their time and efforts to their legislative functions and other official duties without undue constraints;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. RHOLLY A. LABANG**, the body resolved, as it hereby resolves to favorably ask the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to exempt the members of the 12th Sangguniang Bayan of Dumalinao from the implementation of Memorandum No. 195 Series of 2022 of the Municipality of Dumalinao, Zamboanga del Sur.
