FAVORABLY ASKING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO EXEMPT THE MEMBERS OF THE 12TH SANGGUNIANG BAYAN OF DUMALINAO FROM THE IMPLEMENTATION OF MEMORANDUM NO. 195 SERIES OF 2022 OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Rholly A. Labang to favorably ask the Local Chief Executive to exempt the members of the 12th Sangguniang Bayan of Dumalinao from the implementation of Memorandum No. 195 Series of 2022 of the locality;

WHEREAS, the imposition of penalties for absences or tardiness during the flagraising ceremony may unduly burden members of the 12th Sangguniang Bayan, impeding their ability to fulfill their duties effectively;

WHEREAS, it is in the best interest of the municipality to ensure that the members of the Sangguniang Bayan can fully dedicate their time and efforts to their legislative functions and other official duties without undue constraints;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order:

NOW, THEREFORE, premises above-considered, on motion by HON. RHOLLY A. LABANG, the body resolved, as it hereby resolves to favorably ask the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to exempt the members of the 12th Sangguniang Bayan of Dumalinao from the implementation of Memorandum No. 195 Series of 2022 of the Municipality of Dumalinao, Zamboanga del Sur.
