RESOLUTION NO. 0315-2024

FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO ALLOCATE FUNDS FOR THE ACQUISITION OF BODY WORN CAMERAS TO BE USED BY THE MUNICIPAL POLICE OF DUMALINAO FOR THEIR LAW ENFORCEMENT OPERATIONS.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Joel L. Famor to favorably request the Local Chief Executive to allocate funds for the acquisition of body worn cameras to be used by the Municipal Police of Dumalinao for their law enforcement operations;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, ensuring transparency and accountability in law enforcement operations is crucial for maintaining public trust and confidence in the Municipal Police of Dumalinao, particularly in the Anti-Illegal Drug operations in the locality;



WHEREAS, body worn cameras have been proven to be effective tools in providing an accurate record of interactions between law enforcement officers and the public, thereby promoting accountability, protecting both civilians and officers, and enhancing the quality of evidence in investigations;

WHEREAS, the acquisition and utilization of body worn cameras to be used by the Municipal Police of Dumalinao have been identified as a priority by law enforcement agencies across the country;

WHEREAS, the Local Government Unit of Dumalinao recognizes the importance of investing in modern technology to enhance the effectiveness and professionalism of its law enforcement support;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. JOEL L. FAMOR**, the body resolved, as it hereby resolves to favorably requesting the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to allocate funds for the acquisition of body worn cameras to be used by the Municipal Police of Dumalinao for their law enforcement operations.
