

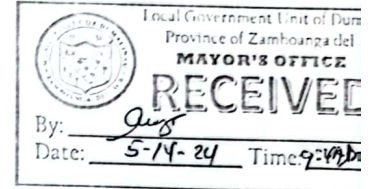

FAVORABLY ENDORSING TO THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD, THE RESOLUTION NO. 04, S. 2024 OF BARANGAY BAGA, ENTITLED "A RESOLUTION EARNESTLY REQUESTING THE MUNICIPAL LOCAL GOVERNMENT UNIT THROUGH HON. MAYOR JUNAFLO R. S. CERILLES FOR FINANCIAL ASSISTANCE FOR THE WATER SYSTEM IN THE AMOUNT OF EIGHT MILLION PESOS (PHP8, 000, 000.00) IN BARANGAY BAGA, DUMALINAO, ZAMBOANGA DEL SUR".

WHEREAS, presented for consideration and appropriate action is the Resolution No. 04, S. 2024 of Barangay Baga, Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Barangay Baga, Dumalinao, Zamboanga del Sur, faces critical challenges in securing adequate access to clean and potable water for its residents;



WHEREAS, recognizing the fundamental necessity of water for health, sanitation, and overall well-being, the Barangay Council of Baga, in Resolution No. 04, S. 2024, has earnestly requested financial assistance from the municipal local government unit, through Hon. Mayor Junaflor S. Cerilles, for the improvement of the water system;

WHEREAS, the requested amount of Eight Million Pesos (Php8, 000,000.00) is deemed essential for the successful implementation of the water system project, which will greatly benefit the constituents of Barangay Baga;

WHEREAS, it is imperative for the municipal government to support initiatives that aim to address the basic needs and enhance the quality of life of its constituents, particularly in disadvantaged communities such as Barangay Baga;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. RHOLLY A. LABANG**, the body resolved, as it hereby resolves to favorably endorse to the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, the Resolution No. 04, S. 2024 of Barangay Baga, entitled "A resolution earnestly requesting the Municipal Local Government Unit through Hon. Mayor Junaflor S. Cerilles for financial assistance for the water system in the amount of Eight Million Pesos (Php8, 000, 000.00) in Barangay Baga, Dumalinao, Zamboanga del Sur".

WHEREAS: Water is a critical resource for the constituents of Brgy. Baga and plays a key role in many aspects of their livelihoods, thus poor access to water and insufficient sanitation affect the health, food security, and their prospects for making a living;

WHEREAS: The Children from School or even the Seniors in this barangay it's difficult to fetch water from the source which is far from each household, especially this sunny season.

WHEREFORE, The Barangay Council of Baga, Dumalinao Zamboanga del Sur, is expecting your immediate action for approval regarding this matter.
