

### RESOLUTION NO. 0317-2024

UPDATING THE ACCOUNT SIGNATORIES OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO AT THE LAND BANK OF THE PHILIPPINES (LBP), PAGADIAN CITY AND AUTHORIZING THE MUNICIPAL VICE MAYOR, HONORABLE WILFREDO L. MALONG, SR., AND THE MUNICIPAL TREASURER, GUALBERTO U. GEMINA, JR., AS AUTHORIZED SIGNATORIES DURING THE ABSENCE OF THE MUNICIPAL MAYOR, HONORABLE JUNAFLOR S. CERILLES, RMT, MAGD, OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, during the absence of the Municipal Mayor, Honorable Junaflor S. Cerilles, RMT, MAGD, of the Municipality of Dumalinao, Zamboanga del Sur, Honorable Vice Mayor Wilfredo L. Malong, Sr., shall act as her alternate in all the transactions of the municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:
