RESOLUTION NO. 0319-2024

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO SUBMIT AN ANNUAL REPORT TO THE 12TH SANGGUNIANG BAYAN OF DUMALINAO ON THE SOCIO-ECONOMIC, POLITICAL, AND PEACE AND ORDER CONDITIONS, AND OTHER MATTERS CONCERNING THE LOCAL GOVERNMENT UNIT PURSUANT TO SECTION 97 OF THE REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabaless to respectfully requesting the Local Chief Executive to submit an Annual Report to the 12th Sangguniang Bayan of Dumalinao on the Socio-economic, Political, and Peace and Order conditions, and other matters concerning the Local Government Unit pursuant to Section 97 of the R.A No. 7160;

WHEREAS, Section 97 of Republic Act No. 7160, also known as the Local Government Code of 1991, mandates that on or before March 31 of each year, every the Local Chief Executive shall submit an annual report to the sanggunian concerned on the socio-economic, political, and peace and order conditions, and other matters concerning the Local Government Unit (LGU) which shall cover the immediately preceding calendar year;



WHEREAS, the submission of such an annual report is crucial for the Sangguniang Bayan to be properly informed of the various conditions and developments within the municipality, thereby enabling the council to make well-informed decisions and policies that will benefit the constituents of Dumalinao;

WHEREAS, the socio-economic conditions of the municipality include, but are not limited to, data and analysis on employment, income levels, business growth, infrastructure development, health, education, and social services;

WHEREAS, the political conditions encompass the governance, administrative efficiency, and the overall political climate of the municipality;

WHEREAS, the peace and order conditions refer to the safety, security, and public order within the locality, including crime rates, law enforcement activities, and community safety programs;

WHEREAS, other matters concerning the LGU may include environmental issues, cultural initiatives, and other relevant topics that impact the municipality and its residents;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to respectfully request the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to submit an Annual Report to the 12th Sangguniang Bayan of Dumalinao on the socio-economic, political, and peace and order conditions, and other matters concerning the local government unit pursuant to Section 97 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
