### **RESOLUTION NO. 032-2022**

RECOMMENDING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES TO CREATE A MUNICIPAL AD-HOC ENFORCEMENT COMMITTEE FOR THE IMPELEMENTATION AND ENFORCEMENT OF LAWS AND ORDINANCES AGAINST ILLEGAL CONSTRUCTION OF BUILDING AND STRUCTURE AND ROAD AND ALLEY OBSTRUCTION IN THE MUNICIPALITY DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposal of Hon, Hermes B. Cabales to recommend the Local Chief Executive to create a Municipal Ad-Hoc Enforcement Committee for the implementation and enforcement of laws and ordinances against illegal construction of building and structure and road and alley obstruction in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Municipal Town Plan of the Local Government Unit of Dumalinao aims and ensure that all buildings, roads, alleys, and parks are in place at the

appropriate site in order to make a community environment that will advance human welfare in health, well-being, and safety as well as to generate economic opportunities and facilitate economic development;

WHEREAS, according to the Municipal Planning and Development Officer there are structures and establishment that was illegally erected and constructed based on the municipal town plan of the locality;

WHEREAS, for the proper negotiations and appropriate action towards the illegal structures that were constructed, the body finds it necessary to create an Ad-Hoc **Enforcement Committee:**
