RESOLUTION NO. 0325-2022

RESOLUTION ADOPTING THE PROVINCIAL ORDINANCE NO. 075-2022, ENTITLED “AN ORDINANCE REQUIRING THE INCLUSION OF TREE PLANTING AND CLEAN-UP ACTIVITIES IN SPECIAL OCCASIONS SUCH AS FOUNDING ANNIVERSARIES, FIESTAS AND DURING ARBOR DAY EVERY 25TH OF JUNE OF THE PROVINCIAL, CITY, MUNICIPAL AND BARANGAY LOCAL GOVERNMENT UNITS OF ZAMBOANGA DEL SUR” IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, Section 16 of Republic Act No. 7160, known as the General Welfare Clause, explicitly provides that “Every local government unit shall exercise the powers expressly granted, and those necessarily implied therefrom for its efficient and effective governance, and shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety and enhance the rights of the people to a balanced ecology”;

WHEREAS, the Local Government Unit of Dumalinao implemented and adopted the program “GO DREAM DUMALINAO” (Green and Organic, Disaster Resilient Communities, Responsible Government, Empowered Individuals and Communities, Agriculture Productivity and Sustainable, and Management for



Sustainable Environment); to protect and conserve the environment and its natural resources in the locality;

WHEREAS, the august body finds the importance of Tree-planting and Clean-up Activities in order to address the recent global heat wave and its threat and adverse effects to the environment;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO G. LIGAN** the body resolved, as it hereby resolves to adopt the Provincial Ordinance No. 075-2022, in the Municipality of Dumalinao, Zamboanga del Sur.




