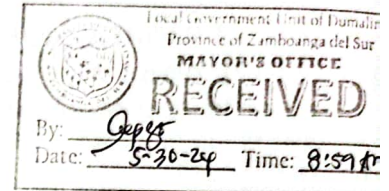

RESOLUTION NO. 0330-2024

ADOPTING THE SUPPLEMENTAL BUDGET NO. 1 OF THE ANNUAL INVESTMENT PLAN (AIP) 2024 OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the Supplemental No. 1 of the Annual Investment Plan 2024 of the Local Government Unit of Dumalinao;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Annual Investment Plan 2023 of the Municipality of Dumalinao includes the different programs and activities per sector and sub-sector, the work activities and financial plan for the 20% Development Plan, 5% GAD Plan, 5% DRRM, 1% PWD and Senior Citizen, 1% LCPC, Inter-Agency Aids, Statutory and



Contractual Obligations, Personal Services, MOOE, Capital Outlay and other funds from other sources of agencies;

WHEREAS, the Supplemental No. 1 of Annual Investment Plan 2024 has a total fund of Thirteen Million Two Hundred Thirty-Four Thousand Forty Pesos and Ninety-One Centavos (Php13, 234, 040.91) for the expenditures of Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay of the different offices of the Local Government unit Of Dumalinao, Zamboanga del Sur;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to adopt the Supplemental No. 1 of the Annual Investment Plan (AIP) 2024 of the Local Government Unit of Dumalinao, Zamboanga del Sur.
