RESOLUTION ADOPTING THE SUPPLEMENTAL NO. 2 OF ANNUAL INVESTMENT PLAN 2022 (AIP) OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, as mandated by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and other pertinent DILG Circulars, provides that every Local Government Unit is mandated to prepare and submit Annual Investment Plan (AIP) to the Department of Interior and Local Government (DILG) and other concerned agencies, for the preparation of its Annual Budget;

WHEREAS, the Annual Investment Plan 2021 of the Municipality of Dumalingo includes the different programs and activities per sector and sub-sector, the work activities and financial plan for the 20% Development Plan, 5% GAD Plan, 5% DRRM, 1% PWD and Senior Citizen, 1% LCPC, Inter-Agency Aids, Statutory and Contractual Obligations, Personal Services, MOOE, Capital Outlay and other funds from other sources of agencies;

WHEREAS, the Supplemental No. 2 of Annual Investment Plan 2022 has a total fund allocation of Two Million Nine Hundred Forty Nine Thousand Five Hundred Fifty One





Pesos and Ninety Four Centavos (PHP2, 949, 551.94) for the personal services remunerations of newly created positions and augmentation of funds under the office of the Municipal Mayor and Sangguniang Bayan;
