RESOLUTION APPROVING THE CHANGE PROJECT TITLE AND LOCATION OF CAPITAL OUTLAY OF THE LINE EXTENSION SINGLE PHASE PRIMARY WITH UB AND OS PROJECT OF BARANGAY METOKONG IN THE SUM OF TWO MILLION TWO HUNDRED NINETY ONE THOUSAND SIX HUNDRED TEN PESOS AND TWENTY FIVE CENTAVOS (PHP2, 291, 610.25) UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO THE FOLLOWING PROJECTS, TO WIT: 1. WHEREAS, the LGU-Dumalinao allocated funds for the abovementioned project in the sum of Two Million Two Hundred Ninety One Thousand Six Hundred Ten Pesos and Twenty Five Centavos (Php2, 291, 610.25);

WHEREAS, the Local Chief Executive request for change of title and project to the following projects of 1. Construction of Coffee and Cacao Building Phase 2 of Barangay Banta-ao amounting to One Million Pesos (Php1, 000, 000.00), 2.
