RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ENTER INTO A CONTRACT OF SERVICE (COS) BY AND BETWEEN MISSING FILEMON BAND REPRESENTED BY EIMER TABASA TO PERFORM A MUSICAL CONCERT FOR THE CELEBRATION OF 66TH ARAW NG **DUMALINAO.**

WHEREAS, presented to this august body for appropriate action is the request of the Local Chief Executive to authorize her to enter into a Contract of Service (COS) by and between Missing Filemon Band represented by Eimer Tabasa to perform a musical concert for the celebration of 66th Araw na Dumalinao;
