RESOLUTION NO. 0341-2024

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, THROUGH THE OFFICE OF MUNICIPAL ENGINEERING TO CONDUCT AN OCULAR INSPECTION OF ALL MUNICIPAL COMFORT ROOMS AND THEIR DRAINAGE AND SUBMIT THE INSPECTION REPORT TO THE OFFICE OF THE SANGGUNIANG BAYAN FOR EVALUATION.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to respectfully request the Local Chief Executive through the Office of Municipal Engineering to conduct an ocular inspection of all municipal comfort rooms and their drainage and submit the inspection report to the Office of the Sangguniang Bayan for evaluation;

WHEREAS, Section 447, (a), (1), Article III, Title II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan, as the legislative body of the municipality, shall pass resolutions necessary for an efficient and effective municipal government;

WHEREAS, it is the duty of the Local Government Unit of Dumalinao to ensure the health, safety, and welfare of its constituents by maintaining proper sanitation and hygiene in all public facilities, including municipal comfort rooms;





WHEREAS, the proper functioning of municipal comfort rooms and their drainage systems is crucial to prevent health hazards and to ensure a clean and sanitary environment for the public;

WHEREAS, there have been reports and complaints regarding the condition of some municipal comfort rooms and their drainage systems, necessitating an immediate and thorough inspection to identify and address any issues;

WHEREAS, the results of such an inspection are essential for the Sangguniang Bayan to evaluate the current state of these facilities and to formulate appropriate measures to address any deficiencies found;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JELITO R. PEÑONAL, the body resolved, as it hereby resolves to respectfully request the Local Chief Executive through the Office of Municipal Engineering to conduct an ocular inspection of all municipal comfort rooms and their drainage and submit the inspection report to the Office of the Sangguniang Bayan for evaluation.
