RESOLUTION NO. 0342-2022

SPECIFYING THE PROJECT TITLE OF THE ALLOCATED CAPITAL OUTLAY UNDER THE OFFICE OF THE MUNICIPAL MAYOR IN ACCORDANCE TO THE SUPPLEMENTAL BUDGET NO. 1 AMOUNTING TO THREE MILLION SIXTY ONE THOUSAND SIX HUNDRED THIRTEEN PESOS AND TWENTY FIVE CENTAVOS (PHP3, 061, 613.25), TO WIT: 1. CONSTRUCTION OF PUBLIC MARKET SIDEWALK ALONG NATIONAL HIGHWAY IN THE SUM OF THREE HUNDRED SIXTY ONE THOUSAND SIX HUNDRED THIRTEEN PESOS AND TWENTY FIVE CENTAVOS (PHP361, 613.25); 2. COMPLETION OF ELECTRICAL STREET LIGHTS ALONG SUMADAT NATIONAL HIGHWAY IN THE SUM OF TWO MILLION TWO HUNDRED THOUSAND PESOS (PHP2, 200, 000.00); AND 3. IMPROVEMENT OF BBQ STALLS BESIDE MUNICIPAL TENNIS COURT IN THE SUM OF FIVE HUNDRED THOUSAND PESOS (PHP500, 000.00) OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented to this august body for appropriate action is the request of the Municipal Planning and Development Officer to specify the title projects of the allocated Capital Outlay under the Office of the Municipal Mayor in accordance to the Supplemental Budget No. 1 amounting to Three Million Sixty One Thousand Six Hundred Thirteen Pesos and Twenty Five Centavos (Php3, 061, 613.25), to wit: 1. Construction Of Public Market Sidewalk Along National Highway In The Sum Of Three Hundred Sixty-One Thousand Six Hundred Thirteen Pesos And Twenty Five Centavos (Php361, 613.25); 2. Completion of Electrical Street Lights



along Sumadat National Highway in the Sum of Two Million Two Hundred Thousand Pesos (Php2, 200, 000.00); and 3. Improvement of BBQ Stalls beside Municipal Tennis Court in the Sum of Five Hundred Thousand Pesos (Php500, 000.00) of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, under Section II, Appropriation Ordinance No. 2022-04-465, dated April 25, 2022, under the Office of the Municipal Mayor, appropriated a sum of Three Million Sixty One Thousand Six Hundred Thirteen Pesos and Twenty Five Centavos (Php3, 061, 613.25) for the construction, improvement, and completion of the above-mentioned projects but did not specify the amount with the title of the projects respectively;

WHEREAS, it is necessary to specify the said projects in order to determine the title and corresponding allocated budget;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES** the body resolved, as it hereby resolves to specify the title projects of the allocated Capital Outlay under the Office of the Municipal Mayor in accordance to the Supplemental Budget No. 1 amounting to Three Million Sixty One Thousand Six Hundred Thirteen Pesos and Twenty Five Centavos (Php3, 061, 613.25), to wit: 1. Construction Of Public Market Sidewalk Along National Highway In The Sum Of Three Hundred Sixty-One Thousand Six Hundred Thirteen Pesos And Twenty Five Centavos (Php361, 613.25); 2. Completion of Electrical Street Lights along Sumadat National Highway in the Sum of Two Million Two Hundred Thousand Pesos (Php2, 200, 000.00); and 3. Improvement of BBQ Stalls beside Municipal Tennis Court in the Sum of Five Hundred Thousand Pesos (Php500, 000.00) of the Municipality of Dumalinao, Zamboanga del Sur.




