RESOLUTION NO. 0342-2024

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD, THROUGH THE OFFICE OF MUNICIPAL ENGINEERING TO CONDUCT AN OCULAR INSPECTION OF BARANGAY PAGLAUM JUNCTION ROAD TO DUMALINAO NATIONAL HIGH SCHOOL AND SUBMIT THE INSPECTION REPORT TO THE OFFICE OF THE SANGGUNIANG BAYAN FOR EVALUATION.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to respectfully request the Local Chief Executive through the Office of Municipal Engineering to conduct an ocular inspection of Barangay Paglaum junction road to Dumalinao National High School and submit the inspection report to the Office of the Sangguniang Bayan for evaluation;

WHEREAS, Section 447, (a), (1), Article III, Title II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan, as the legislative body of the municipality, shall pass resolutions necessary for an efficient and effective municipal government;

WHEREAS, the road from Barangay Paglaum junction to Dumalinao National High School is a vital thoroughfare for the residents, students, and the general public;

WHEREAS, it has come to the attention of the Sangguniang Bayan that the condition of the aforementioned road may require urgent assessment and possible maintenance for the safety and convenience of its users, especially in this rainy season;

WHEREAS, it is imperative to ensure that all municipal roads are maintained to the highest standards to prevent accidents and promote smooth transportation;

WHEREAS, an ocular inspection by the Municipal Engineering Office is necessary to determine the current state of the road and to identify any needed repairs or enhancements;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to respectfully request the Local Chief Executive through the Office of Municipal Engineering to conduct an ocular inspection of Barangay Paglaum junction road to Dumalinao National High School and submit the inspection report to the Office of the Sangguniang Bayan for evaluation.
