RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, THROUGH THE RURAL HEALTH UNIT OF DUMALINAO TO CONDUCT AN INFORMATION EDUCATION CAMPAIGN RELATIVE TO PREVENTION AND MITIGATION OF DENGUE OUTBREAK AND THE IMPLEMENTATION OF A 4 O'CLOCK HABIT ADVOCACY PROGRAM OF THE DEPARTMENT OF HEALTH IN ALL BARANGAYS IN THE MUNICIPALITY OF DUMALINAO. ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to respectfully requesting the Local Chief Executive through the Rural Health Unit of Dumalinao to conduct an Information Education Campaign relative to the prevention and mitigation of dengue outbreak and the implementation of a 4 o'clock habit advocacy program of the Department of Health in all barangays in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:

WHEREAS, dengue fever is a significant public health concern that poses a serious threat to the well-being of the residents of Dumalinao;

WHEREAS, the prevention and control of dengue outbreaks require concerted efforts and active participation from the entire community;

WHEREAS, the Department of Health (DOH) has advocated for the implementation of the 4 o'clock habit, a nationwide practice of daily community clean-up drives at 4 PM to eliminate mosquito breeding sites and prevent the spread of dengue;

WHEREAS, there is a need to intensify information and education campaigns to raise awareness and educate the public on effective measures to prevent and mitigate dengue outbreaks;

WHEREAS, the active involvement of the LGU-Dumalinao through the Rural Health Unit of Dumalinao is crucial in disseminating information and mobilizing community efforts against dengue;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to respectfully requesting the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, through the Rural Health Unit of Dumalinao to conduct an Information Education Campaign relative to the prevention and mitigation of dengue outbreak and the implementation of a 4 o'clock habit advocacy program of the Department of Health in all barangays in the Municipality of Dumalinao, Zamboanga del Sur.
